

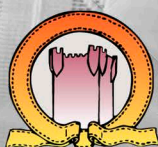

SHORT FILMS IN COMPETITION**

**RULES**

1. Participation in this competition is open to short films of foreign production.
2. Films shot in any format, silent or with incorporated sound, may be presented. With foreign nationality. Produced after July 1, 2019, which have not been registered in previous editions of this festival.
3. The maximum duration of the films in competition will not exceed 30 minutes.
4. Films must be presented with audio in Spanish or in the original version in Spanish or English.
5. Each author may submit up to a maximum of 3 works.
6. Two official sections are established; one to contest and another informative. The selection committee will choose among all the short films received, those that will be part of the competition and those that will do so in the information section. The exhibition copies of the selected films will be returned once the Festival is over.
7. The selected films will appear in the Festival Catalog and will be exhibited in public sessions within the dates of the Festival. The screening dates will be announced through the Festival Program.
8. The decisions of the Selection Committee and the Jury are final.

The copies, in their projection format, of the winning Short Films will remain the property of the Festival, which will only use them for non-profit purposes.

**THE REGISTRATION PERIOD ENDS ON JANUARY 15, 2021**

#### **SELECTED FILMS**

1. The works selected for the competition will be announced on the Festival's website. Confirmation will be previously sent by email to each selected.
2. The exhibition copy of the selected shorts must be uploaded to the link provided in DCP or HD format with a minimum resolution of 1920 x 1080 -1080p- before February 26, 2021.

#### **AWARDS**

The selected films will be eligible for the following prizes, which will be awarded by an Official Jury and by vote:

- **FIRST PLACE** - € 2,000 and ROEL.
- **SECOND PLACE** - € 1,000 and ROEL.
- The Young Jury (young volunteers attending the Festival) will vote for **THE YOUTH AWARD** € 500 and ROEL.  
Sponsored by the Youth Council of the Medina del Campo City Council

All prizes are subject to the withholdings determined by the law in force in Spain.

The incorporation of any other award that does not appear in these rules will be announced in a timely manner through the Festival's communication channels (website, press release, etc.)

#### **GENERAL RULES**

- The authors of the works selected for the competition may present their film if they wish, before the screening.
- The producers of the selected short films authorize the use of a fragment of the works up to a maximum of three minutes, for possible dissemination in any media.
- The Organization may exhibit the selected short films at the places and times it deems appropriate.
- Any additional information or clarification will be provided by mail, telephone or e-mail addressed to the Festival Venue.
- All participants, because they are, fully accept these rules, as well as the resolution by the Organization of any problem not included in these.
