

Tehran International Short Film Festival (TISFF) is an essential platform for both emerging and established filmmakers, arguably one of the most important showcases for short films not only in Iran, but also in the region.

The festival is a qualifying festival for the Academy Awards® (Oscars) and it hosts international well known festival directors and cineasts from around the world. TISFF is a member of International Short Film Conference (ISFC) enabling different players in the short film world to work together and share their experience in an informal, non-political and flexible atmosphere.

TISFF is organized by the Iranian Youth Cinema Society (IYCS). Iranian Youth Cinema Society (IYCS) is an independent educational film organization which has been established over 40 years ago. IYCS is associated to the Iranian Ministry of Culture and has 70 branch offices around the country.

Activities of IYCS is in 3 fields:

- 1- Management of short film festivals.
- 2- IYCS is one of the oldest film schools in the country and perhaps in the world with more than 70 branch offices all around the country. It educates youth in compacted one- year film course.
- 3- Production and distribution of short films.

Awards & Prizes

Tehran International Short Film Festival (TISFF) is a qualifying festival for the Academy Awards® (Oscars) and winner of the Grand Prix become eligible for Oscar® consideration.

Grand Prix: Trophy + Diploma + \$2000

Best Fiction: Trophy + Diploma + \$1000

Best Documentary: Trophy + Diploma + \$1000

Best Animation: Trophy + Diploma + \$1000

Best experimental: Trophy + Diploma \$1000

Rules & Terms

TO QUALIFY FOR COMPETITION, FILMS MUST BE COMPLETED AFTER January 1st, 2021.

- Films completed prior to this date risk disqualification.
- Films containing nudity or violence would not be accepted.

- Although there are no limitations on the subject and categories, but due to the approach of the Iranian Youth Cinema Society in supporting innovation and diversity in cinema, short films that use genre in innovative way would have a higher priority.

- Films must not exceed 30 min running time.

- The list of the selected films will be published on the festival's website (<http://www.tisff.ir>) by 1st of September.

- Films should not have been screened in the previous editions of the TISFF - even in a newer version.

- Industrial and commercial films are not accepted.

- Films which have already been publicly broadcast or distributed in any form or screened-in Iran are not accepted.

- Once the film has been selected and confirmed, the film cannot be withdrawn from the festival program

-Only completed films are eligible for consideration, works in progress or unfinished films will not be considered.

-Iranian shorts should submit in the national section, and they have to use this platform:

Iranian shorts for the international section will be selected through interaction between the National and International Selection teams.

NOTE: The criteria for Iranian entries are that the film's main producer is an Iranian citizen or permanent resident.

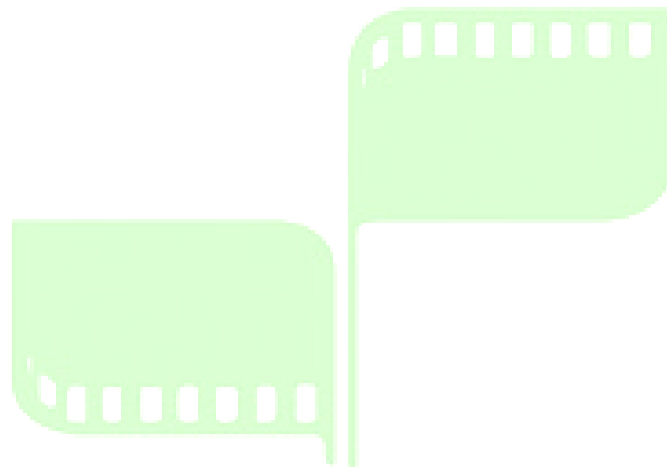
-A pre-selection committee, appointed by the festival for each category, will watch all submissions and make the final selection. We are not able to give feedback on films or reasons for the committee's decisions.

- If selected for competition, we require 2 files immediately which must be delivered or transferred in 10 days after selection announcement:

1. FHD Mp4/mov. H.264 10bit video file, without any attached subtitles
2. subtitles and transcription of dialogues with time code in their original

language with translations only in English (even if the language of the film is English).

- By submitting to the festival you approve that either you are the right owner of the project or have the legal rights to distribute the submitted project.
